

# PROGRAM OVERVIEW

Please join us for the 2021 UVA Controversies in Liver Disease and Liver Transplantation at the Wintergreen Resort in Wintergreen, VA.

Experts in the field will present on topics that are highly relevant for practicing gastroenterologists, hepatologists, primary care physicians, physician assistants, nurse practitioners, nurse anesthetists, nurses, social workers, nutritionists and anyone involved with providing patient care for liver disease before, during and after transplantation. Topics of focus include alcohol use and the liver transplant candidate, donor liver machine perfusion, what to expect the day of transplant, changing indications for patients with cancer and transplant oncology, adult-to-adult living donor liver transplantation, medical and endoscopic management for esophageal varices and hypertensive bleeding, acute liver failure and nutrition, frailty and the liver transplant candidate. The half-day in-person program will conclude with an engaging mock selection committee comprised of physicians, nursing, social work and nutrition.

At the completion of this program, participants should be able to:

- Discuss the changes in liver transplant evaluation for patients with alcohol related cirrhosis.
- Express the fundamental ideas that support liver machine perfusion and its potential impact on the future of liver transplantation.
- Understand the events in the perioperative period of liver transplant.
- Describe what a patient can expect on the day of transplant.
- Explain new indications for liver transplantation related to malignancy and other oncologic indications.
- Determine the impact of the changing allocation system for patients with HCC.
- Identify medical and endoscopic management strategies for the treatment of esophageal varices and portal hypertensive bleeding.
- Evaluate the appropriate candidates to utilize the potential benefits of living donor liver transplant in the modern US liver allocation system.
- 9 Emphasize the benefits for community providers and their patients in working collaboratively and openly with the transplant center.
- Define interventions that maximize nutrition and minimize frailty in the liver transplant candidate.
- Recognize a multifaceted approach for every liver transplant candidate to include requirements and gray zones for approval and listing for transplant candidates.
- Understand the latest management and transplant strategies for patients with acute liver failure and differentiate that process from acute on chronic liver failure.


